Towards a sustainable future in Myanmar.

Myanmar has seen profound socio-economic changes in the past decade. Myanmar's Human Development Index (HDI) value increased from 0.349 to 0.584 between 1990 and 2018[1]. Life expectancy at birth increased by 10.0 years, mean years of schooling increased by 2.5 years. Gross National Income per capita increased by about 689.1 percent during the same period. However, loss of HDI value due to inequality is 23.2 percent for 2018, which is higher than the East Asia and the Pacific average of 16.6 percent. Myanmar's Gender Inequality Index (GII) that shows gender-based inequalities in reproductive health, empowerment and economic activity, is 0.458, ranking it 106 out of 162 countries in 2018. UNDP's Multidimensional Poverty Index (MPI) shows that 38.3% of the population is living under multidimensional poverty, which is the highest in Southeast Asia. Multiple studies by the government shows that vulnerability is increasing: Total amount of land illegally confiscated in 2016 amounted to 2 million acres according to the government's farmers' affairs committee[2]; Ministry of Home Affairs report shows that sexual violence against women has been increasing year by year[3]. Poverty and vulnerability is pushing people out of the country, as seen in the 2014 census that recorded over 2 million people migrating to other countries and internal migration is increasing[4].

This conference calls for researchers doing empirical studies on Myanmar to share cutting edge knowledge and grassroots research on contemporary development issues in Myanmar. Perspectives on Myanmar's development path is of interest to national and international academicians, policy makers, donors and development practitioners alike because of its ethnic diversity, complex history and political changes
